This is to ensure that accurate information as to the representation type is getting put into the system and is always available to any FPD should they need that for reporting or statical purposes.
PTS	Representation for sentencing hearing only on prisoner transfer case is opened as PTS	We added this new code for when the representation is only for the SENTENCING HEARING on a prison transfer, and NOT the prisoner transfer nor does it have anything to do with the transfer itself. This again, was to help ensure the accuracy of the representation and the information that was entered into the system.
DSOPT	Representation for a prisoner transfer case in which the case is ONLY assigned by DSO to the FDO	We added a new code for this type of representation due to the fact that these cases are only assigned by DSO to the FDO office and DSO is responsible for all the funding for these cases. They have no input from the courts.

GCP	Representation in which individual is Gang Court Participant	Districts are starting to have their own Gang Courts, which are very similar to Drug Court, and they are using the ODC, OT or ANC to open their cases with. These types of representation should have it's own opening code so that it can be properly tracked and referenced.
VCP	Representation in which individual is Veterans Court Participant	Districts are starting to have their own Veterans Court, which again are very similar to Drug Court, and they are using the ODC, OT or ANC to open their cases with. These types of representation should have it's own opening code so that it can be properly tracked and referenced.
SA	Representation of an individual in an appeal of a final sentence or conviction based on a plea.	Based on what we had learned from other offices, a large number of them were opening their appeals as CA. The thought was that you only opened an appeal of a JURY TRIAL as a TD and everything else as a CA. Since appeals opened under the CA code don't deal with the final disposition of a case (jury or plea) we felt it best to leave the TD and CA codes in place and add the SA code for appeals dealing with "non-jury" issues, i.e. where a defendant appeals the length of their sentence, or their conviction based on their plea. Most of these types of appeals are already being opened under the CA code, they would now be opened under the SA code.
DCP	Drug Court Participant	Replaces ODC
DPCC	Appointment of FDO as Co-Counsel on a death penalty case.	We added all of these new codes with regards to capital cases because if any attorney is appointed to a capital case in any of these

		situations, they can only enter the correct timekeeping codes if the case is designated as a death penalty case. For instance, if an attorney is appointed to a death penalty case as co-counsel and you open the case under the CCA code (co-counsel appointment) the system does not allow the attorney to enter any timekeeping codes related to capital work. They can only enter time related to "trial" work if you will. Therefore, we added the additional "miscellaneous representations" to the capital section as well.

M4243C and M4253E - Mental Disease	These are actually part of M4243A which is the hearing and should not be addressed separately
PO - Petty Offense	This opening code was removed because it is not an actual case type but an offense level. Any type of case in which an individual is charged with violating a statute which only amounts to an offense level of petty is still a criminal case (CR) and therefore would be opened as such.
SS - State Statute	This opening code was removed because it is not an actual case type but more accurately describes the governing offense charged. Any type of case in which an individual is charged with violating a statute, whether federal or state, is a criminal case (CR) and therefore would be opened as such.
MNT - Motion for a New Trial	This opening code was removed because it does not actually represent the charged offense(s). The offense(s) for which an individual has been charged, and for which the new trial was granted, are what should be used as the basis for opening the case in Ddata.
RTL - Remand (Trial Level)	Same as above
